## Our Story

Founded in 1977, EVE (originally known as the Council Against Domestic Assault, or CADA) was Lansing's first domestic violence program, providing a safe shelter for women and children experiencing domestic violence.

Today, EVE's services have grown to provide support programs to EVE's residents and non-residents, including advocacy, counseling, crisis intervention, children's programs and community education.

## Our Services

EVE's programs and services are client centered, confidential, FREE of charge, and designed to empower survivors.

Our programs use a nonjudgmental, supportive and strengths based approach. Survivors of all racial, ethnic and religious backgrounds, gender identities and sexual orientations are welcome.

All staff and volunteers are trained to meet the special needs of survivors and their children. Counseling services are provided by masters and doctoral level staff and interns in the social work, psychology and counseling fields. All interns are supervised by experienced staff on-site as well as faculty from area universities.

## Our Programs

- **24-hour Crisis Line (517) 372-5572**—Crisis intervention, client support, information and referrals.
- **Shelter**—Temporary safe housing, meals and personal care items.
- **Advocacy**—Case management services to assist clients with their medical, financial, employment, legal aid, housing and transportation needs.
- **Counseling**—Individual and family counseling, and support groups for women and children.
- **Personal Protection Order Office**—Technical assistance and information on the process of filing a Personal Protection Order, advocacy and court support.
- **Children's Services**—Parenting classes, children's support groups, children's activities. Prevention education for youth aged 12-18; parent workshops on talking to children about healthy and unhealthy relationships.
- **Community Education**—Local community presentations on domestic and dating violence and EVE's services.
- **Dating violence prevention education**—Program designed to help protect middle school- through college-aged youth from physical, emotional and sexual abuse in dating relationships.
- **Domestic Violence Support Unit**—advocacy services at Ingham County Sheriff's Office, Mason.

Programs are available to shelter residents and non-residents. You do not need to live in Ingham County to receive services. Bilingual services are available.
